Dr Anna Chioti is the Head of the Division of Pharmacy and Medicines within the Directorate of Health / Ministry of Health Luxembourg.

In this position, she is building the national regulatory capacity, while developing the legal and organisational framework of the future Agency for Medicines and Health Products of Luxembourg, focusing on innovative, adaptive and pragmatic regulatory schemes.

Medical doctor specialized in GP and in Public Health, with a Master in Business Administration, and a Master in European Legal Studies, her field of expertise ranges from general clinical practice & preventive medicine, public health & clinical research to pharmaceutical & regulatory affairs. Her career track includes clinical experience in ambulatory and hospital setting, as well as several years in the pharmaceutical industry and in academic/public research.

Born Greek and Danish and educated in Belgium, she lives in Luxembourg since 2010, where she developed the Clinical and Epidemiological Investigation Centre within the Luxembourg Institute of Health. She managed to build a well-established research unit, bringing in expertise in pharmaceutical and regulatory affairs, while managing numerous clinical research projects, in oncology, infectious diseases, nutrition, diabetes or cardiology. Before joining the Ministry of Health, Dr Chioti was leading the Department of Population Health of the Luxembourg Institute of Health. She is also involved in several national healthcare strategic groups, boards of several professional and scientific societies in Luxembourg and internationally. Since 2022, Dr Chioti is the chair of the Science and Innovation panel of the EU Innovative Health Initiative.
